## **DISCUSSION**

The following is intended to provide the Board with an overview of the current staffing pressures being addressed by the Service.

Contained within Table A are the current actual headcount for both sworn and civilian positions (exclusive of econded positions). Within the table all members that are not fully-deployable or absent from work are identified in one of the nine categories. Those categories are:

- Permanent Accommodations –members with medical (or other restrictions that are not expected to recover to the point of being fully deployable.
- 2. Temporary Accommodation members with medical (or other) restrictions that are expected to recover and become fully deployable.
- WSIB Off work- members off work with a work place injury.
- 4. WSIB Temp Accommodation members temporarily accommodated as a result of a work place injury.
- 5. Long term disability a member currently on long term disability, and counted within actual strength.
- 6. Suspension members currently suspended with pay.
- 7. Paternity leave members currently on paternity leave.
- 8. Maternity leave members currently on maternity leave.
- 9. Non-occupational Short term off sick members currently off sick as a result of an illness or injury that is non-work related.
- 10. Unpaid administrative leave members currently off work for reasons other than medical

In total the DRPS currently has 101 sworn and 54 civilian staff not fully deployable. Of the 101 sworn 44 are not at work, and of the civilian staff 23 are not at work. The 101 and 54 staff represents 11.5% and 17.8% of the Service's total sworn and civilian staff.
